

COPYRIGHT NOTICE

This Copyright Notice (the “Notice”) governs the use of game materials (the “Assets”) from the video game “STALZONE” specified on <https://stalzone.com/> (the “Game”), developed and published by EXBO EAST LLP (Republic of Kazakhstan), Registration Number: 221140035112 (the “Rightholder”).

By downloading, opening, or using any Assets from this package, you (the “User”) unconditionally accept the terms of this Notice in full.

If you do not agree to the terms of the Notice, please delete all files from this package immediately and refrain from using them.

1. SUBJECT MATTER

1.1. The Rightholder grants the User a limited, royalty-free, non-transferable, revocable right to use the Assets worldwide solely in accordance with the terms of this Notice.

1.2. Assets may include 3D models, textures, animations, sounds, UI elements, concept art, and other digital materials, as well as technical files included in this package.

1.3. All rights in the Assets, including exclusive proprietary rights, remain with the Rightholder. This Notice does not transfer any intellectual property rights to the User.

2. PERMITTED USE

2.1. The User is permitted to:

- create non-commercial creative works based on the Assets, including fan art, illustrations, renders, fan fiction, and other derivative materials;
- use the Assets in video content (YouTube, Twitch, and similar platforms), including monetized content through platform partner programs, provided that the Assets themselves are not the primary commercial product;
- include the Assets in non-commercial projects such as mods, fan maps, educational projects, and other materials not intended for commercial gain;

2.2. The Assets may be used in gaming content creation (streams, reviews, walkthroughs, and similar content) related to the Game.

2.3. Use of the Assets does not, under any circumstances, release the User from the obligation to comply with the current End-User License Agreement governing the use of the Game (https://exbo.games/legal/gl_licence.pdf or https://exbo.games/legal/egs_eula).

3. PROHIBITED USE

3.1. The User is strictly prohibited from:

- using the Assets for any commercial purpose – selling, licensing, or otherwise transferring them for consideration, whether as a standalone product or as part of a commercial product (including NFTs, prints, merchandise, and similar goods);
- integrating the Assets into commercial game projects, mobile applications, software, or other products sold for consideration or monetized based on the Assets themselves;
- using the Assets in the creation or promotion of cheats, cheat clients, hacking tools, automation scripts, or any other tools that violate the Game’s rules or disrupt gameplay;
- using the Assets in materials that advertise, promote, or facilitate unauthorized access to software, hacking, exploits, or any other infringement of the Rightholder’s exclusive rights or third parties’ rights;
- using the Assets in materials that violate applicable law, defame the Rightholder, or damage the reputation of the Game;

4.2. Any breach of the terms of this Notice results in the immediate and automatic termination of all rights granted to the User hereunder.

4.3. Upon termination of the license, the User must immediately cease all use of the Assets and destroy all copies in their possession.

4.4. The Rightholder reserves the right to seek compensation for damages caused by a breach of this Notice in accordance with applicable law.

5. LIMITATION OF LIABILITY

5.1. THE ASSETS ARE PROVIDED “AS IS” WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED. THE RIGHTHOLDER SHALL NOT BE LIABLE FOR ANY DAMAGES ARISING FROM THE USE OR INABILITY TO USE THE ASSETS, INCLUDING DIRECT, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES.
